
How LPA Funding works

- FHWA provides Federal Funding to states including Missouri
- MoDOT and Metropolitan Planning Organizations (MPOs) administer the funding
- MoDOT provides funding via agreements to Local Public Agencies
- Local agencies typically hire consultants and contractors to complete their infrastructure projects

LPA Programs

- BRO/BFP Off System Bridge Replacement
- TAP Transportation Alternatives Program
- FLAP Federal Land Access Program
- TEAP Traffic Engineering Assistance Program
- STBG Surface Transportation Block Grant
 - Limited to KC, St Louis, and Springfield
- CMAQ- Congestion Mitigation and Air Quality
 - Limited to KC and St Louis Metro areas

Example LPA Project process

- 1) MoDOT* posts call for projects
 - LPAs apply
 - Regional committees evaluate and rank project applications
 - MoDOT posts selected projects

* Some areas have programs administered by Metropolitan Planning Organizations (MPOs)

2) Consultant selection

- LPAs may design in house
- Typically select consultant to design and often for Construction Engineering services
- If under \$200,000 in engineering expenses LPA may use on call list
 - Consultant must be in all applicable categories of work needed
 - 3 consultants must be contacted.
- RFQ process is required for services over \$200,000
 - Minimum 2 week posting and is on a scheduled calendar for postings.
- Design includes Environmental an Historic Preservation services
- Design may also include ROW procurement services

3) Design

- Preliminary plans
- Environmental an Historic Preservation services
- ROW procurement services
- Plans Specs and Estimates
- Bidding services

3a) Environmental and historic preservation

- Projects must be submitted into MoDOT's Request for Environmental Review system
 - Typically completed by LPA
 - Later turned over to consultant
- MoDOT utilizes consultants to provide oversite of the environmental and historic preservation reviews.

3b) Right of way acquisition

- Started after environmental review is complete
 - With limited early acquisition exceptions
- Not necessary for all projects.
- ROW training needed for LPA ROW negotiators and appraisers
- MoDOT utilizes consultants to provide oversite of ROW acquisition reviews.

4) Bidding/award of the project

- Must be advertised on MoDOT's Projects to be let by Others website
- Must be advertised locally
- Must be posted a minimum of 3 weeks
- Must have obligation prior to posting
- Must seek MoDOT's concurrence prior to award

5) Construction

- Work cannot start prior to NTP
- Requires CE oversite
- Closeout documentation critical
 - 3 year audit period

How we set goals

- We consider the following criteria when evaluating projects for goals:
 - Location
 - Dollar amount (contract value)
 - Work types / subcontracting opportunities
 - NAICS Codes
 - Availability of DBE firms and past utilization
 - Similar past projects
- Goal setting steps:
 - Determining the projects scope of work
 - Identify DBE opportunities based upon each line item
 - Utilize the MRCC Directory
 - Calculate the DBE % maximum
